**NOTE :**

1. All pensioners are advised to submit the above information to the Office of Pr.CCA, DoT, Hyderabad and the Head of the Office from where the Govt. Employee retired.
2. Attested photocopy of any one of the following documents in support of date of birth of the spouse/eligible family member may be submitted.
  - i) PAN card
  - ii) Matriculation Certificate (containing the information regarding date of birth)
  - iii) Passport
  - iv) CGHS card
  - v) Driving License(if it contains date of birth)
  - vi) Voter's ID Card may also be accepted as proof of date of Birth subject to following conditions :
    - (a) The pensioner/family pensioner certifies that he is not a matriculate
    - (b) The pensioner certifies that he/she does not have any of the documents mentioned from i to v.
  - vii) In case pensioner/family pensioner is unable to submit any of the documents mentioned above (i) to (vi) but claims additional pension based on some other documentary evidence such cases will be submitted to the administrative ministry whose decision in this regard will be final (DP&PW Order No. 38/37/08-P&PW(A) dated 21.05.2009, 11.08.2009 & 28.09.2010 may be referred to).
3. The above information will help to expedite the cases. In the absence of the above information/Application, the process of revision of pension/family pension may be delayed and the case revised as per the records available with Head of Deptt/Head of Office.
4. In case their documents have already been provided to the Bank from where pension is being disbursed, mention may be made of the fact.
